WINTER FARE MARKETS

The goal of Winter Fare is to bring people a taste of the great locally grown food that is available year round and to educate people about ways they can incorporate more locally grown foods into their diets throughout the winter. For this reason, **we have established the following criteria for vendors:**

- All unprocessed foods must be grown by the vendor;
- Vendors' primary products must be edible. Secondary non-edible agricultural products may be sold, and
- All value-added products sold must include a primary ingredient that is locally grown or raised.

The market coordinators reserve the right to select vendors based on the following considerations:

- Geographic location,
- Diversity of product at the market, and
- Date of application
